NOTICE OF RACE  
2017 DILLON YACHT CLUB SEASON SERIES  
Lake Dillon, Colorado

You are cordially invited to participate in the 2017 Dillon Yacht Club (DYC) Summer Series of Regattas, a series of regattas to be held starting June 10, 2017 and concluding October 7, 2017. The Dillon Yacht Club is the Organizing Authority (OA).

1. RULES

- 1.1. These regattas will be governed by the rules as defined in 2017-2020 The Racing Rules of Sailing (RRS).
- 1.2. This Notice of Race and amendments, the Sailing Instructions and any changes made to the Sailing Instructions posted on the Official Notice Board at the DYC Clubhouse will apply.
- 1.3. The following Racing Rules will be changed as follows:
  - 1.3.1. When AP is displayed ashore: the first warning signal will be no sooner than 30 minutes after lowering the AP flag.
  - 1.3.2. Add to RRS: 41 (e) help to recover from the water and return on board a crew member provided the return on board is at the approximate location of the recovery.
  - 1.3.3. RRS Appendix A2: Scoring, see Section 11.

2. ADVERTISING

- 2.1. Competitor advertising will be restricted as follows: Advertising, if any, must comply with USSAILING and World Sailing guidelines.
- 2.2. Boats may be required to display advertising chosen and supplied by the organizing authority.

3. ELIGIBILITY AND ENTRY

- 3.1. The regattas are open to all members of the Dillon Yacht Club.
- 3.2. DYC members intending to compete in any of the Series must prepay in advance for all regattas before the season begins (see 11.6), and will qualify to be included in the final overall season standings. The entry form may be found on line at [www.dillonyachtclub.com](http://www.dillonyachtclub.com).
- 3.3. Boats may enter individual regattas by completing the entry form on the day of the regatta. Competitors must submit the entry form and pay the entry fee prior to the competitors meeting.
- 3.4. All boats competing must display the mainsail number identical to the number in which they registered with, or report to the RC a change in the sail number PRIOR to the start of racing that day. It shall be the responsibility of each participating boat to obtain and affix the proper sail numbers to all sails. The RC may protest a boat for breaking this requirement and the penalty shall be a 20% scoring penalty for all races in which the infraction occurred.
- 3.5. For boats intending to compete in any of the Series, Helmsperson must be a full member of the Dillon Yacht Club.
- 3.6. It is the skipper's responsibility to carry liability and casualty insurance to cover all potential and actual claims and losses and to provide proof thereof; and, it is the skipper's obligation to provide the crew members' signature regarding this waiver of liability. To the extent the skipper does not obtain that crew member's waiver of liability, the skipper shall be liable for

any such claims, demands and causes of actions and shall hold the DYC harmless from the same.

4. CLASSES

- 4.1. Three (3) or more one-design boats registered in the Sumer Series, or in an individual weekend regatta will constitute a fleet for the series or individual regatta.
- 4.2. Any fleet of less than three boats may race in the PHRF class.
- 4.3. If a boat does not have a SAIL PHRF rating, the Organizing Authority will assign a rating to that boat.

5. FEES

5.1. Required fees are as follows:

6. SCHEDULE

6.1. Registration: 1:00 PM on the day of each race. A competitors meeting may be held at 1:00 PM on the first day of each regatta.

6.3. Number of races: 8 races are scheduled for each weekend series. Races will be sailed back to back.

6.4. The scheduled time of the warning signal for the first race each day will be 2 PM.

6.5. No races will be started after 6:00 PM on Saturdays and 5:30 PM on Sunday.

## 7. MEASUREMENTS

7.1. Each class shall be responsible for insuring that individual boats comply with measurement and class rules.

## 8. SAILING INSTRUCTIONS

8.1. The sailing instructions will be available online at [www.dillonyachclub.com](http://www.dillonyachclub.com) and in the DYC clubhouse.

## 9. VENUE

9.1. Attachment A shows the location of the Dillon Yacht Club and marina.

9.2. Attachment B shows the location of the racing area on the main portion of the Dillon Reservoir.

## 10. THE COURSES

10.1. The location of racing marks is shown in Attachment B. The RC shall post the marks to be rounded and the order in which they are to be rounded.

## 11. SCORING

11.1. RACE SCORES: Races will be scored according the RRS A2 with the following modifications: There will be one throw-out after four races.

11.2. PHRF scoring will use the Sailing Association of Intermountain Lake PHRF time on time correction using the formula:

$$\text{Corrected time} = 715 / (515 + \text{PHRF Handicap}) * \text{Elapsed time.}$$

11.3. Any boat that has not paid its racing fees will not be scored.

## 12. PRIZES

12.1. Weekend regatta prizes and acknowledgement on the DYC Clubhouse Display will be presented to each "fleet" (see 4.1 for class fleets) based on the number of registered entries for that individual regatta.

12.2. DYC Summer Series prizes will be presented to the top 3 finishing boats in each fleet (see 4.1 for eligible class fleets) and will be awarded by the OA at the DYC Awards Banquet.

## 13. COMMUNICATIONS

13.1. The RC will monitor VHF Channel 69 for all communications.

13.2. Failure to hear ANY RC transmission shall not be grounds for requesting redress.

13.3. In the event of an on the water emergency, call 911.
